Iyadoo la tixgelinayo Xeerka (EU) 2018/848 ee Baarlamaanka Yurub iyo Golaha 30 May 2018 ee organic wax soo saarka iyo calaamadaynta alaabta dabiiciga ah iyo burinta Xeerka Golaha (EC) Maya 834/2007 (¹), iyo gaar ahaan Maqaal 12(2)(a) iyo Maqaal 15 (2) (b) iyo (c) ka mid ah,

Halka:

- (1) Komishanka loo wakiishay Xeerka (EU) 2020/427 (²) ayaa leh dhawaan wax laga beddelay dhibic 1.3 ee Qayb I ee Lifaafa II ilaa Xeer-nidaamiye (EU) 2018/848 leh ixtiraam ku organic soo baxay abuur ku hubi iyaga wax soo saarka ka organic abuur. Marka la eego in iniinaha soo baxay ay ku jiraan sprouts, caleemaha iyo cress (³), kaas oo si gaar ah u isticmaali kara kaydka iniinaha biqilka, biyaha kaliya waa in loo isticmaalo wax soo saarka organic. Sidaa darteed, waxaa loo baahan yahay in la caddeeyo in hoos u dhac ka yimid beerashada ciidda la xidhiidha iniinaha biqil waxay ku kooban tahay qoyaynta iniinaha waana in si cad loo sheegaa in aan la ogolayn isticmaalka dhexda beeranaysa, marka laga reebo isticmaalka dhexdhexaad aan shaqaynayn si abuurku u qoyaana marka qaybaha ka kooban yahay . ee in dareen la'aan dhexdhexaad ah yihiin idman gudaha u hoggaansanaanta leh Maqaal 24 ee Xeerka (EU) 2018/848.
- (2) Marka la eego madaxyada chicory, wareeggooda wax soo saarka gaarka ah waxay ka koobnaan karaan laba ka mid ah wejiyada koowaad ee ciidda iyo mid la yiraahdo 'qasab waji', kaas karaa noqon gudaha ciidda, laakiin sidoo kale gudaha biyo ama substrates. Sidaa darteed, waa waa lagama maarmaan ah ku cadee in ah derogation ka beerashada la xiriira ciidda madax chicory ka mid ah qoto dheer in cad biyaha iyo in isticmaalka a koraya dhexdhexaad ah waa ogol yahay kaliya Goorma ay qaybaha yihiin idman gudaha u hoggaansanaanta leh Maqaal 24 ee Xeerka (EU) 2018/848.
- (3) Maqaal 251 (3) (b) ee Xeerka Komishanka (EC) Maya 889/2008 (⁴) loo ogol yahay kolestaroolka organic in loo isticmaalo in lagu kabo quudinta dabiiciga ah marxaladda soo baxaysa iyo marxaladihii hore ee nolosha ee shrimps penaeid iyo cawska biyaha saafiga ah (*Makrobrachium* spp.). Sidaa darteed waa lagama maarmaan in la bixiyo kabidda quudinta leh kolestaroolka organic si loo shrimps-kaas iyo cawska ee dhibicda 3.1.3.4 ee Qaybta III ee Lifaafa II ee Xeerka (EU) 2018/848.
- (4) Sannadka 2019, markii laga doodayo qabyo-qoraalka Xeerka Wakiilada (EU) 2020/427, qaar ka mid ah Dawladaha Xubnaha ka ah waxay codsadeen dib u eegis lagu sameeyo xeerarka kale ee la xidhiidha aquaculture organic. Kooxda khabiriirka ah ee talobixin farsamo oo ku saabsan wax soo saarka organic (EGTOP) dhigay kor by Komishanka Go'aan 2017/C 287/03 (⁵) la qiimeeyay kuwaas codsiyada. - (5) Iyadoo aan loo eegin shuruudaha la xiriira ka-hortagga cudurrada, sida talada xakamaynta noolaha ee dulin leh doorbidid ku noqon la siiyo ku ah isticmaal ee nadiifiye kalluunka iyo ee biyo macaan, badda biyo iyo sodium koloriin xalalka, a xaddidan tirada ee daawaynta, gudaha kiis ee daran dulin dhacdo, waa hadda loo ogol yahay si guud oo dhan noocyada. Iyada oo ku saleysan gabagabada EGTOP ee kor ku xusan, way habboon tahay wax ka beddelka qodobbada hadda jira ee ku saabsan daawaynta dulin ee ku xusan qodobka 3.1.4.2 ee Qaybta III ee Lifaafa II ee Xeerka (EU) 2018/848 by isbarashada a dheeraad ah nooc-gaar ah habayn ku ka fiican ciwaanka ah baahida ee beeralayda xoolaha la'aanteed tanaasulid ah organic dabeecadda ee ah wax soo saarka.

Sidaa darteed, noocyada kale ee aan ahayn salmon, waxay ku habboon tahay in la isku hagaajiyo inta jeer iyo ugu badnaan tirada ee dulin daawaynta leh ah inta jeer xad dhigay waayo kale kiimikaad ahaan allopathic synthesized caafimaadka xoolaha daawo alaabta ku ogolaansho ku faragelin Goorma waa waa runtii lagama maarmaan ah iyo ku iska ilaali dhimashada sare gudaha ah marka hore marxaladaha ee ah nolosha wareegga.

Lifaaqa II ku Xeerka (EU) 2018/848 waa wax laga beddelay sida soo socota:

(1) gudaha Qayb aniga, dhibic 1.3 waa beddelay by ah soo socda:

1.3. By hab ee hoos u dhigid ka dhibic 1.1, ah soo socda waa noqon la ogol yahay:

- (a) soo saarista iniin biqil, oo ay ku jiraan sprouts, caleemaha iyo cress, ee ku nool kaydka nafaqeynta oo keliya. la heli karo gudaha ah abuur, by qoyan iyaga gudaha cad biyo, la siiyay in ah abuur yihiin organic. The isticmaal ee koraya dhexdhexaad ah waa noqon mamnuuc, marka laga reebo ah isticmaal ee ah dareen la'aan dhexdhexaad ah loogu talagalay kaliya ku hayn ah abuur qoyan Goorma ah qaybaha ka mid ah in dhexdhexaadin aan caqli-gal ahayn loo oggolaaday si waafaqsan qodobka 24;
- (b) ah helid ee chicory madax, oo ay ku jiraan by quusin iyaga gudaha cad biyo, la siiyay in ah dhirta taran maadada waa organic. Isticmaalka koraya dhexdhexaad ah in la oggolaado oo keliya marka qaybaheeda la oggolaado si waafaqsan qodobka 24.;

(2) Qayb III waa wax laga beddelay sida soo socota:

(a) gudaha dhibic 3.1.3.4. ah soo socda Baaragaraaf waa ku daray:

Gudaha ah koraan-bax waji iyo gudaha hore nolosha marxaladaha gudaha xanaanooyinka iyo hatchery, organic kolestaroolka laga yaabaa noqon loo isticmaalo si loo kabo cunnooyinka shrimps penaeid iyo cawska biyaha macaan (*Macrobrachium* spp.), si loo sameeyo ammaankooda tiro ahaan cunto baahan;

(b) gudaha dhibic 3.1.4.2. dhibic (e) waa beddelay by ah soo socda:

(e) isticmaalka daaweynta dulinka, kuwa kale marka loo eego nidaamyada xakamaynta qasabka ah ee ay ku shaqeeyaan Dawladaha Xubinta ka ah, waa inay loo xaddido sida soo socota:

- (i) waayo salmon, ku ugu badnaan laba koorsooyin ee daaweynta per sanad, ama ku mid koorasada ee daaweynta per sanad xagee wax soo saarka wareegga waa ka yar ka badan 18 bilo;
- (ii) waayo dhammaan noocyada kale ka badan salmon, ku laba koorso ee daaweynta per sanad, ama ku mid koorasada ee daaweynta per sanad xagee ah wax soo saarka wareegga waa ka yar ka badan 12 bilo;
- (iii) waayo dhammaan noocyada, ku maya dheeraad ah ka badan afar koorsooyin ee daaweynta gudaha wadarta guud, iyadoon loo eegin ee ah dhererka ee ah wax soo saarka wareegga noocyada;'
